## **Membership Report**

- National Region 4 Vice President, Preet Damani, gave a report about the current membership of Oklahoma SkillsUSA
  - As of Jan. 17, membership stands at 16,633 members
  - Exceeds last year's membership by 1,089
  - Largest membership is state's history
- 32 schools completed the TPP plan

### **Director's Report**

- Northeast District Director Teresa Piper gave a report over the director's meeting on Jan. 18
  - Five members were present
  - Discussed limiting the number of contestants per instructor at the district conference due to lack of space
  - Discussed SLI- narrowed to two locations in OKC
  - SLI theme, limiting conference to 3 days
  - State officers mentoring district officers
  - Job interview competition has a portfolio, required but not judged
  - Revising the Lauren De La Rosa scholarship

#### **Advisor's Report**

- Kendra Alcala gave the Advisor's Report
- Oklahoma SkillsUSA website has been remade
  - Issues on the site may be related to internet browsers
- Communication
  - Members and advisors can sign up for the weekly emails
  - State officers plan to give tips on the emails twice a month
  - State officers will facilitate zoom meetings in the future for
  - State officer candidates
- Financial issues
  - Contestants aren't being charged registration fees for certain contests
  - Issue will be further investigated
  - Students taking practice tests without competing is causing money loss for the organization
  - Kendra Alcala and Renee Reed discussed that an error had been found in the registration system for regional and district contests. An advisor from a competing school notified the State Advisor that their invoice was not being billed correctly and after looking more into the issue it

was found that contestants participating in two contests were not being charged for one of their contests.

- Kendra Alcala is working with national SkillsUSA to figure out the issue in the system and will have a list of school affected.
- With the cost of supplies and materials needed to run contests across the state it is important that registration is correct and being paid correctly.
- Council discussed the impact of losing contest registration.
  - This may have been an issue for years.
- State Advisor will correct current issues and moving forward contestants will pay for each contest they participate in.
- Also, State Advisor will check on State level registration to make sure this issue is not occurring in that registration as well.
- Ethan Murphy made a motion for Kendra to fix registration fees so students are charged the correct amount
  - Seconded by Mark Pennington
  - Motion passed
- National Leadership and Skills Conference
  - More information will be available in the future
  - Community service opportunity will be altered
  - Oklahoma will be lodging in the same hotel
